### **SOOSAIYA PETER EDUCATIONAL TRUST**

Soosaiya Peter Educational Trust was founded by the Philanthropist and Business tycoon Dr. S. Peter on October 3, 1996, Chennai. This is a registered Christian Minority Trust. The Trust, under the Madha Group of Academic Institutions, has founded Madha Engineering College, Madha College of Nursing, Madha College of Physiotherapy, Madha Teacher Training Institute, Madha College of Education and Madha Matriculation Hr. Sec. School on Somangalam Road, Kunrathur, in the lush green environs of the Chembarambakkam reservoir. Under Loordhu Ammal Educational Trust, the same (Madha) Group has established Madha Medical College & Research Institute, Madha Arts & Science College, Our Lady College of Education, Our Lady Matriculation Hr. Sec. School & Madha Public School

The Madha Dental College & Hospital which is a PG institute lies at a distance of 0.75 km from Kunrathur bus stand approachable from four directions namely, from Pallavaram, Poonamalle, Sriperumbudur and Chennai. State transport buses are available at 10 minutes frequency. The college is well developed with excellent infrastructural facilities in permanent buildings. The main building is a four-storeyed framed structure with a total area of over 4,500 sq.m. (50,000 sq. ft) with practical demonstration blocks for various laboratories separately for Dental College. The College owns a 350-bed full-



fledged free General Hospital to teach medicine and surgery for Dental and medical students.

Playgrounds for Basketball, Volleyball and Badminton are available. There are separate Hostels within the campus for the Boy and Girl students, which can accommodate up to students. The hostel rooms are well-lit, ventilated and spacious. Steam cooking pantry, veg. & non-veg. food, common rooms with recreational facilities like T.V., Newspapers, Magazines and Indoor games are available



## **Aims and Objectives**

9. Comprehend the overview of Dental research and the importance of research in dentistry practice.
10. Participate and conduct research studies to improve the body of knowledge in our profession.
11. Demonstrate communication skills within the profession as well as in inter-disciplinary professional subjects.
12. Develop leadership abilities to initiate and bring about changes in all areas of practice.

## **PROGRAMME DETAILS OF DENTAL EDUCATION**

The program is spread over four years of study and one year of CRRI. House Surgency or Compulsory Rotary Internship - The House Surgeons have only 12 days of casual leave per year, except for the prescribed holidays by the Tamilnadu Dr. MGR University

## **FACULTY**

A team consisting of highly qualified and experienced Principal and faculty members for the various disciplines renders service with dedication and commitment to this noble profession. The College is set to perform a brilliant innings in the years to come. We commit ourselves towards the welfare of the students, staff and others in the college, the state of Tamilnadu and the country as well. Our aim is to impart high-quality education to the students while inculcating in them discipline, devotion to studies and dedication to the countrymen of this great country.

## **AFFILIATION & RECOGNITION**

This Institution is approved by the Government of Tamil Nadu and affiliated to T.N. Dr. M.G.R. Medical University and affiliated by the Dental Council of India.

## **Eligibility Criteria**

The students pursuing their studies in this college are admitted as per the norms prescribed by the Tamil Nadu Dr.M.G.R. Medical University.

## **College Infrastructure**

The Dental College has developed with full-scale infrastructural facilities in permanent building. The main

building is a four-storeyed framed structure. It has a total area of over 50,000 sq. ft.

### **Lecture Halls :**

The College has a spacious and sufficient number of lecture halls that can accommodate 100 students per lecture hall. The rooms are well-furnished, ventilated and have a conducive atmosphere that stimulates academic learning.

### **Demonstration Halls :**

There are also separate Halls to carry out demonstrations as well as practicals with a sufficient number of equipment and accessories for the students to practice.

### **RURAL HEALTH SERVICES**

This Institution has adopted Sirukulathur, Kundrathur & Nandambakkam, Village to render the service to the rural people and it runs the Dental Clinic which provides total dental care.

## **ATTENDANCE REQUIRED FOR ADMISSION TO EXAMINATION:**

Each academic year shall consist of not less than 280 working days. No candidate shall be permitted to any one of the parts of the B.D.S. examination unless he/she has attended the course in the subject for the prescribed period in an affiliated institution recognized by this University and produces the necessary certificates of study, attendance and satisfactory conduct from the Head of the Institution.

- A) A candidate is required to put in a minimum of **75 % attendance** in both theory and practical/ clinical separately in each subject before admission to the examination.
- B) A candidate lacking in the prescribed attendance in theory and practical/clinical, in any one subject, in the first appearance shall not be permitted for admission to the entire examinations.
- C) 75 % attendance for the additional period is compulsory.

## **APPRAISAL**

The performance of students is assessed by a system of:

1. Periodical internal assessment in theory and practicals.
2. Apart from the University Examination, the college has its own mode of assessing the student's academic and clinical performance from time to time. The student is expected to maintain high academic and clinical performance standards throughout the program

## **CLASSIFICATION OF SUCCESSFUL STUDENT**

A successful candidate who secures 60% or above of the marks in the aggregate in his / her first appearance will be declared to have passed in the First Class in that particular subject and a successful candidate securing 75% or above of the marks in the aggregate in any subject in the first appearance will be declared to have passed the examination in the subjects with Distinction.

First Class may be awarded to such candidates who have passed all the subjects of the first appearance and obtained 60% of marks and above in all the subjects he/she had appeared.

Candidates who have passed all the subjects at the first appearance and obtained 75% of marks and above in all the subjects he/she had appeared shall be awarded First Class with Distinction.

All other successful candidates shall be declared to have passed in second class.

## **EXEMPTION FROM RE-EXAMINATION IN A SUBJECT**

Candidates who failed in the examination but obtained pass marks in any subject shall be exempted from re-examination in that subject.

## **FEES AND PAYMENT**

At the time of admission, fees as prescribed by the Government should be paid. Tuition fees and other fees of each semester should be paid by the students of all categories which will be made known at the time of selection / admission. No student will be allowed to attend

classes unless he/she complies with all the admission requirements and pays all the fees for the semester. The fees are subject to change.





## **GENERAL RULES AND REGULATIONS**

- Every candidate who has been admitted and enrolled into this college should register within one week of the reopening of the subsequent year by paying the prescribed tuition fees, hostel fees and other fees
- The defaulters are subject to the penal provisions prescribed by the Principal from time to time.
- If the student fails to clear the arrears of fees within 3 weeks, his / her name shall be struck off from the rolls.
- Students should produce their N.O.C. from the management, before getting their HALL TICKETS.
- If the student is admitted in college, he/she is expected to continue for the whole period of the course. If anyone wishes to discontinue, he/she has to pay the fees for the remaining period of the course.

## **GENERAL BEHAVIOUR:**

The students of Madha Dental College are expected to maintain certain high principles like dignity, politeness, honesty and neatness.

1. **The college starts at 8.30 a.m. and closes at 3.30 p.m.**
2. Ragging is strictly prohibited. Students indulging in the same are liable for severe punishment including dismissal from the college / hostel. The issue will be referred to the police, as ragging has been declared as a criminal offence by the Tamil Nadu Government.
3. Students found responsible for any damage to the college building, furniture or equipment will be penalized and the cost of damages will be recovered

from them. The college reserves the right to expel such students.

4. Continuous absence from classes is a serious breach of discipline and may result in expulsion from the college.
5. No student shall take part in any anti-social or subversive activity. No students shall be members of any organization or association not connected with the college.
6. Students are forbidden from organizing Unions or associations based on caste, colour, creed, language, nationality, religion or political ideology within the campus.
7. Students should not use drugs, liquor, or smoke within the college campus. Violation of this rule shall be seriously dealt with and will lead to the dismissal of the student from the college/ hostel.
8. During the meetings and functions of the college, students are expected to conduct themselves in good behavior and discipline. And misbehaviors will attract disciplinary action.
9. Students must conduct themselves in a fitting manner at all times so as to bring credit to themselves and to the college. Attendance is compulsory on the re-opening day of the college, failing which, stringent action will be taken.
10. Visitors will not be allowed to meet the students during class hours. However, under unavoidable circumstances, they shall be permitted to meet the students with permission from the Principal.
11. The college maintains absolute discipline and students violating this are liable for severe penalties including expulsion.
12. Students expelled on the ground of indiscipline, will not be entitled to any certificates or refund of fees and deposits.

13. They should wish their faculty, other staff and among themselves with Good morning.
14. The students should compulsorily wear their I.D. Cards prominently inside the college campus.
15. While going from one hall to another they should move in an orderly manner.
16. Students are expected to be in their respective classes before the commencement of the classes.
17. No student should leave the hall without availing permission from the faculty mem
18. Habitual neglect of class work or homework shall be deemed as a breach of discipline and may render a student to be sent out of a class.
19. A student already suspended twice, will be dismissed immediately without any enquiry
20. Students shall occupy only seats allotted to them at the beginning of the year and any violation will attract penalty.
21. Girl students should wear churidar with dupatta inside the campus. Half-sleeves and leggings are not allowed. Boy students should wear only formal and jeans are not allowed.
22. All the students both boys and girls should wear overcoat within the campus.
23. Girl students should tie up the hair/plait or put it inside the coat while in the laboratory and clinics.
24. Dental girl students should not wear finger rings and bangles
25. Using lipsticks, mehendi and nail polish are not allowed.
26. Use of mobile phones is strictly PROHIBITED inside the college campus.
27. Students should wear a neat, clean white over-coat in the laboratory and clinics
28. During class hours, whether the lecturer is present or not students should remain inside their classrooms.

## **HOSTEL ADMISSION RULES AND REGULATIONS**

1. Application for admission to the hostels should be made in the prescribed form. A passport-size photograph must be affixed in the application form. A student seeking hostel admission must give an undertaking in writing that he or she will abide by the rules of the hostels. This shall be endorsed by the parent or local guardian in writing.
2. The management reserves the right to refuse admission to the hostels to any student without assigning any reason or to expel any member in the interest of the administration.
3. A student admitted to the hostel for a particular year should pay the fees for the entire period of one year regardless of the date of joining.
4. A student who joins the hostel is expected to stay for a minimum period of one academic year and anyone leaving the hostel before the completion of the period will forfeit the Hostel fees paid.
5. The student, who once reserves his seat by paying the fees for hostel **accommodation**, will not be eligible for a refund if he/she chooses not to stay in the hostel.

## **GENERAL RULES AND REGULATIONS OF THE HOSTELS**

1. The Principal shall be the ex-officio chief warden and his decision will be final on all matters regarding discipline, administration and finance. He shall be

assisted by wardens of 'Soosaiya Pillai Boys' and 'Arul M a r y Girls' Hostel.

2. Inmates of each room are jointly responsible for the furniture, electrical fittings, etc., and any damage to the hostel property is recoverable from them.
3. Ragging in any form is strictly PROHIBITED, and those who violate this rule will be expelled from the hostel as well as from the college.
4. No female guest can be entertained in the Boy's hostel; likewise, no male guest can be entertained in the Girls Hostel.
5. Uses of drugs, alcohol any kind of gambling are strictly prohibited.
6. Students are not permitted to entertain any day-scholar / guest to stay with them, without prior permission from the resident warden.
7. In case of serious illness and infectious disease, the student should bring this to the notice of the resident warden immediately.
8. The use of any electrical appliances in the rooms is forbidden.
9. Students are advised NOT to keep valuables or excess cash with them.
10. Writing on the walls or pasting of any material on the walls, windows or doors are strictly prohibited.
11. Students should not organize or address any meeting in the hostel.
12. Students are permitted to go out with prior permission of the resident warden. Details of rules for permission can be had from the warden. While going out, they should

- submit the permission card and sign in the movement-register.
13. When the student is permitted to go out, he/she should report on time; failing which further permission will not be granted.
  14. Permission will not be given for tuition and computer classes outside.
  15. Students should not stay in the local guardian's home during the night without submitting their parent's letter to the principal and getting approved. **For the local guardian's home visit and for the visit to home town, parents are requested to send the letters directly to the Principal. Letters through e-mail are not entertained.**
  16. When parents come to Chennai for any other purpose, they can come to the college and pick up their wards with our permission. Asking the students to come to the place where they are staying over the phone is not allowed.
  17. Other than parents and authorized local guardians, nobody will be allowed to see their wards. **Girl** students should not take their friends along with them to see their respective visitors.
  18. Phone calls from parents and authorized local guardians alone are encouraged.
  19. Hostel students should not board the college buses since the buses are only for the day-Scholars.
  20. Only letters received from parents will be given to their wards.

21. Students have to make their choice for vegetarian or Non-Vegetarian food at the beginning of the year and shall continue to be so far the whole period of their stay.
22. Lights should be switched off at 11.00 p.m. This rule will be waived during examination time.
23. Any student, who wishes to vacate the hostel must inform to the Principal before March **31<sup>st</sup>**. He/she can vacate only after the completion of the academic year.
24. Students can stay in the hostel, only up to the last regular exam. After that, those who vacate the hostel have to pay and stay in the hostel.
25. Disciplinary action will be taken against inmates who violate the hostel rules. In all matters of discipline, the decision of the principal is final. Students who are expelled from the hostel on disciplinary grounds shall forfeit fees and deposit.
26. Food from outside (friends and relatives) should be checked by the respective warden before they give it to the students.
27. Boys are permitted to go out for 2 hours once in a week and for girls once in 15 days with prior permission from the respective resident warden.
28. Boys are permitted to visit the local guardian once in 15 days and girls can visit once in a month.
29. Students should report to the hostel after visiting local guardian or after vacation leave, only between 06.00 a.m. to 06.00 p.m. on the scheduled date.
30. Parents should visit their ward in hostel only on Sundays between 10.00 a.m. and 06.00 p.m. or prior intimation should be given to the principal in case of emergency.

31. Students with arrears will not be permitted to visit the local guardian and they are not entitled for the study leave.
32. The resident Warden and the Chief Warden will monitor the above rules.
33. Hostel inmates should observe the study hours from 8.00 PM to 11.00 PM
34. Students using Laptop or computers have to submit a requisition for utilization with necessary fees.

## **ACADEMIC INFORMATION**

The college intends to impart the Dental education in an excellent manner.

1. For every 10 students of the college a Faculty member is nominated who advises, assists and monitors their problems. A record is kept for this purpose with the respective faculty member (Staff advisor).
2. The staff advisor keeps the HOD and Principal informed about the student's progress, their problems, etc, and obtains remedial measures.
3. The parents shall meet the Principal at least twice a year and get feedback about their ward's welfare and progress in studies.
4. Every effort shall be taken to obtain the best results in the University examinations.
5. Students shall bring only the prescribed notes and books to the class.
6. They should be regular in submitting assignments and attending tests. Internal marks shall be based on their performance in these tests only.



## **INTERNAL ASSESSMENT TESTS**

1. The scheme, syllabi and regulations for every batch is included in the calendar. They shall keep their calendar with themselves and closely follow the classes and monitor the proper coverage of the subject.
2. Monthly tests, 3 Terminals, and assignments shall be conducted and the students shall be kept in full readiness to face the examinations at any time. Also, faculty shall keep them in good stead to perform well in the examination.
3. Those who do not do well shall be encouraged to come up. In case there is a lacuna or negligence on the part of the student the matter shall be brought to the notice of her parents and their reply shall be filed. Such of students who do not show progress in the weekly tests and assignments and do not pay sufficient attention may not be allowed to appear for the University examination.
4. Before the University examination a model examination shall be conducted and the student's performance shall be evaluated.

## **LIBRARY**

Library facilities are available for the staff and the students of this college. All students and staff of the college are the members of the library and are entitled to borrow books from the library.

The library and the reading room shall be kept open on all working days. The library has more than 5000 volumes of Medical and Dental books and journals. A qualified Librarian is in charge of the library and is assisted by library assistants.

The digital library has a number of video cassettes showing various techniques and various methods of treating the patient in various conditions. In addition, different forms of visual aids such as overhead projectors and slide projectors are used to impart effective teaching.

In addition, newspapers and weekly magazines in English, Tamil, Telugu & Malayalam are provided in the library and hostel to facilitate the students of other states.

## **RULES OF THE LIBRARY**

1. The Library will be kept open for the students and staff between 8.00 a.m. and 8.00 p.m. on all working days and on Saturdays too.
2. Strict silence is to be observed in the library and students should conduct themselves as required.
3. Any misconduct like tearing of sheets from books, mutilation of books, marking inside and folding pages,

etc., will be dealt with seriously and the cost of such books at the prevailing rates will be recovered from the concerned student, besides imposing a fine.

4. Facilities for photocopying of pages from books are available in the library. The student should pay for the services rendered then and there and a receipt must be obtained from the Librarian / Library assistant.
5. Students should leave the books on the table after reading and are not expected to replace them on the racks.
6. Each student is eligible to borrow 2 library books at a time.
7. On receiving a book, the student should examine the condition of the book. If any damage is found, it should be brought to the notice of the librarian immediately. Otherwise, he/she will be held responsible for the damage.
8. Students will be allowed to keep a book for 15 days from the date of issue.
9. A book may be renewed for another period of 15 days. If the book is retained beyond the due date without renewing, the student's library membership will be suspended.
10. Journals and reference books will not be issued to anybody.
11. Every member is expected to handle the books and magazines of the library with utmost care.
12. The librarian is empowered to send out any student who misbehaves in the library.
13. All student members should return the library cards at the end of the year and obtain a "No Due Certificate".

## **RAGGING - AN OFFENCE**

Ragging in any form, any place or at any time is a cognizable offense that will attract severe punishment including expulsion from the College / Institution / University.

Extract of Tamil Nadu Govt. Gazette - Extraordinary dt. 29.01.1997 (Bill No. 8 of 1997 Tamil Nadu Prohibition of Ragging Act)

1. In this act, unless the context otherwise requires, “Ragging” means display of noisy, disorderly conduct, doing any act which causes or is likely to cause physical or psychological harm or raise apprehension or fear or shame or embarrassment to a student in any educational institution and includes: -
  - a) Teasing, abusing or playing practical jokes on, or causing hurt to such student; or
  - b) Asking the student to act or perform something which such student will not, in the ordinary course, willingly act or perform.
2. Ragging within or outside any educational institution is prohibited.
3. Whoever directly or indirectly commits, participates in, abets, or propagates “Ragging” within or outside any educational institution shall be punished with imprisonment for a term that may extend to two years and shall also be liable to a fine which may extend to ten thousand rupees.
4. Any student convicted of an offense shall also be dismissed from the educational institution and such student shall not be admitted in any other educational institution.

Without prejudice to the foregoing provisions, whenever any student complains of ragging to the head of an educational institution, or any other persons responsible for the management of the educational institution, such head of the educational institution, or person responsible for the management of the educational institution shall inquire into the same immediately and if found true, shall suspend the student, who has committed the offense, from the educational institution.

## **TRANSPORT REGULATIONS**

1. The transport facility is provided for staff and students for easy accessibility to college, from different parts of Chennai.
2. There are 25 buses catering to the needs of the staff and students. They operate through various important routes covering all main areas of Chennai.
3. The buses reach the college campus by 8.15 a.m. and leave the college at 4.15 p.m.
4. Students should come to the College by College Buses only.
5. The students should carry the identity cards while boarding the bus.
6. Separate seats are allotted for girls and Boys. No boy student should share seat with a girl student and vice-versa. Seat Reservation is strictly prohibited.
7. Travel on foot-board is strictly prohibited.

8. Violation of any of the transportation rules or misbehaviour inside the bus will be viewed seriously and necessary disciplinary action will be taken.

## **CODE OF ETHICS**

In order, the dignity and honor of the dental profession may be upheld its standards exalted, its sphere of usefulness extended and the advancement of Dental science promoted and understand more clearly their patients and to the community at large, the following code ethics is prescribed.

It is the duty of every dentist to govern himself on accordance with underlying principles which have motivated the formulation of the code. It is not assumed that the following articles cover the whole field of dental ethics, the addition to those set forth herein. Briefly the “Golden rule” should be conscientiously applied by every member of the dental profession.

It is unprofessional for a dentist to advertise by handbills, posters, circulars, cards and signs or in newspapers or in publications calling attention to special methods of practice or claiming excellence over other practitioners or to use display advertisements of any kind. It is also unprofessional to publish reports of class or certificates in public prints. This does not exclude a practitioner, either from using professional cards of suitable size with name, titles, address and telephone number printed in modest type or having the same character of card in a newspaper at the time of commencement of practice or change of address for not more than these three insertions of time. Neither specially from merely announcing his specialty on his profession card.

It is unprofessional for the dentist to pay or accept commission on fees for professional services or radiograms or any other articles supplied to patients by pharmacists or others.

One dentist should not disparage the services of another to a patient criticism of operations that are apparently defective may be unjust through lack of knowledge of the conditions under which they were performed. But the welfare of the patient is paramount to every other consideration. Should be conserved to the most of the practitioner's ability if he finds indisputable evidence that a patient is suffering from previous faulty treatment, it is his duty to institute correct treatment at once doing it with as little comment is possible and in such a manner as to avoid reflection on his predecessor.

If a dentist is consulted in an emergency by the patient of another practitioner who is temporarily absent from his office, patient who is away from home, the duty of the dentist so consulted is to relieve the patient of any immediate disability by temporary service only and then refer the patient back to regular dentist.

When a dentist is called in consultation by fellow practitioners he should hold the discussions in the consultation as confidential and under no circumstances should he accept charge of the case without the request of the dentist who has been attending it.

It is unethical for dentists to connive at or aid in illegal by others. It is their duty to expose such persons without fear or favor.

It is unethical for dentists to give testimonials directly or indirectly concerning the supposed virtue of secret therapeutic medicines or agents or to promise radical cures by employing secret methods of treatment.

The dentist should be normally, mentally and physically clean. He should be honest in all dealings with his fellowmen as comports with the honor and dignity of a cultured and professional gentleman.

### **DENTISTS ACT 1948**

The All India Dental Journal and IDA review provided an effective medium for the dissemination of scientific advances and stressed the need for ethical practice in the field of Dentistry.

The IDA founded in 1946 highlighted the necessity for regulating the practice of dentistry and this resulted in the enactment of the Dentist Act 1948. This proved a turning point in the history of dental education and introduced a regulated systematic practice of dentistry. The provisions of the act stipulated that the practice of dentistry without registration was a punishable offense with the intention of eliminating quackery and standardizing educational requirements. The DCI was constructed in 1949, at the central and state levels.



## **CODE OF CONDUCT FOR STUDENTS**

The students of Madha Dental College are expected to maintain certain high principles like dignity, politeness, honesty and neatness.

1. The college starts at 8.45 a.m. and closes at 3.45 p.m.
2. Ragging is strictly prohibited. Students indulging in the same are liable for severe punishment including dismissal from the college/hostel. The issue will be referred to the police, as ragging has been declared as a criminal offense by the Tamil Nadu government.
3. Students found responsible for any damage to the college building, furniture or equipment will be penalized and the cost of damages will be recovered from them. The college reserves the right to expel such students.
4. Continuous absence from classes is a serious breach of discipline and may result in expulsion from the college.
5. No student shall take part in any anti-social or subversive activity. No students shall be members of any organization or association not connected with the college.
6. Students are forbidden from organizing unions or associations based on caste, colour, creed, language, nationality, religion, or political ideology within the campus.
7. Students should not use drugs, liquor, or smoke within the college campus. Violation of this rule shall be seriously dealt with and will lead to the dismissal of the student from the college/hostel.
8. During the meetings and functions of the college, students are expected to conduct themselves in good behavior and discipline. And misbehaviors will attract disciplinary action.

9. Students must conduct themselves in a fitting manner at all times so as to bring credit to themselves and to the college. Attendance is compulsory on the re-opening day of the college, failing which, stringent action will be taken.
10. Visitors will not be allowed to meet students during class hours. However, under unavoidable circumstances, they shall be permitted to meet the students with permission from the principal.
11. The college maintains absolute discipline and the students violating this are liable for severe penalties including expulsion. Students expelled on the grounds of indiscipline will not be entitled to any certificates or refund of fees and deposits.
12. They should wish their faculty, other staff and among themselves with Good Morning.
13. The students should compulsorily wear their I.D. cards prominently inside the college campus.
14. While going from one hall to another should move in an orderly manner.
15. Students are expected to be in their respective classes before the commencement of the classes.
16. During class hours, whether the lecturer is present or not students should remain inside their classrooms.
17. No student should leave the hall without availing permission from the faculty member.
18. Habitual neglect of classwork or homework shall be deemed as a breach of discipline and may cause a student to be sent out of class.
19. A student already suspended twice, will be dismissed immediately without any enquiry.
20. Students shall occupy only seats allotted to them at the beginning of the year and any violation will attract penalty.

21. Girl students should wear churidar with dupatta inside the campus. Half sleeves and leggings are not allowed. Boy students should wear only formals and jeans are not allowed.
22. All the students both boys and girls should wear white-coat within the campus.
23. Girl students should tie up the hair/plait or put it inside the coat while in the laboratory and clinics.
24. Dental girl students should not wear finger rings and bangles.
25. Usage of lipsticks, mehendi, and nail polish are not allowed.
26. Usage of mobile phones is strictly PROHIBITED inside the college campus.
27. Students should wear a neat, clean, white overcoat in the laboratory and clinics.

## **CODE OF CONDUCT FOR STUDENTS ADMITTED IN HOSTEL**

1. The Principal shall be the ex-officio chief warden and his decision will be the final on all matters regarding discipline, administration and finance. He shall be assisted by wardens of “Soosaiya Pillai Boys” and “Arul Mary Girls” hostel.
2. Inmates of each room are jointly responsible for the furniture, electrical fittings, etc., and any damage to the hostel property is recoverable from them.
3. Ragging in any form is **strictly PROHIBITED**, and those who violate this rule will be expelled from the hostel as well as from the college.

4. No female guest can be entertained in the boy's hostel; likewise, no male guest can be entertained in the girl's hostel.
5. Usage of drugs, alcohol any kind of gambling are strictly prohibited.
6. Students are not permitted to entertain any day-scholar/guest to stay with them, without prior permission from the resident warden.
7. In case of serious illness and infectious diseases, the student should bring this to the notice of the resident warden immediately.
8. The use of any electrical appliances in the rooms is forbidden.
9. Students are advised NOT to keep valuable or excess cash with them.
10. Writing on the walls or pasting of any material on the walls, windows or doors is strictly prohibited.
11. Students should not organize or address any meeting in the hostel.
12. Students are permitted to go out with prior permission of the resident warden. Details of permission rules can be obtained from the warden. While going out, they should submit the permission card and sign in the movement register.
13. When the student is permitted to go out, he/she should report on time, failing which further permission will not be granted.
14. Permission will not be given for tuition and computer classes outside.
15. Students should not stay in the local guardian's room during the night without submitting their parent's letter to the Principal and getting approved. **For the local guardian's home visit and for the visit to home town, parents are**

**requested to send the letters directly to the Principal. Letters through email are not entertained.**

16. **When parents come to Chennai for any other purpose, they can come to the college and pick up their wards with our permission. Asking the students to come to the place where they are staying over the phone is not allowed.**
17. Other than parents and authorized local guardians nobody will be allowed to see their wards. Girl students should not take their friends along with them to see their respective visitors.
18. Phone calls from the parents and authorized local guardians alone are encouraged.
19. Hostel students should not board the college buses since the buses are only for the day-scholars.
20. Only letters received from parents will be given to their wards.
21. Students have to make their choice of vegetarian or non-vegetarian food at the beginning of the year and shall continue to be so for the whole period of their stay.
22. **Lights should be switched off at 11.00 pm.** This rule will be waived during examination time.
23. Any student, who wishes to vacate the hostel must inform the principal before March 31<sup>st</sup>. He or she can vacate only after the completion of the academic year.
24. **Students can stay in the hostel, only up to the last regular exam. After that, those who vacate the hostel have to pay and stay in the hostel.**
25. Disciplinary action will be taken against inmates who violate the hostel rules. In all matters of discipline, the decision of the principal is final. Students who are expelled from the hostel on disciplinary grounds shall forfeit fees and deposits.

26. Food from outside (friends and relatives) should be checked by the respective warden before they give it to the students.
27. Boys are permitted to go out for 2 hours once in a week and for girls once in 15 days with prior permission from the respective resident warden.
28. Boys are permitted to visit the local guardian once in 15 days and girls can visit once in a month.
29. Students should report to the hostel after visiting the local guardian or after vacation leave, only between 06.00 a.m. to 06.00 p.m. on the scheduled date.
30. Parents should visit their ward in the hostel only on Sundays between 10.00 am and 6.00 pm or prior intimation should be given to the principal in case of emergency.
31. Students with arrears will not be permitted to visit the local guardian and they are not entitled to the study leave.
32. The resident warden and the Chief Warden will monitor the above rules.
33. Hostel inmates should observe the study hours from 8.00 pm to 11.00 pm. During this period, they are informed to only read and not be involved in any record writing work.
34. Students using laptops or Computers have to submit a requisition for utilization with necessary fees.

## **CODE OF CONDUCT FOR DEAN/ PRINCIPAL/ FACULTIES**

As an employee of the institution, every staff member has a responsibility to uphold the values and standards expected of a doctor and teacher.

**PROFESSIONALISM:**

Faculty members should conduct themselves in a professional manner at all times, demonstrating integrity, respect, and ethical behavior.

**FAIRNESS AND EQUITY:**

Faculty members should treat all students fairly and equally, without discrimination or bias based on factors such as race, gender, culture, religion, or caste.

**RESPECT FOR DIVERSITY:**

Faculty members should embrace and value diversity in all its forms, recognizing and appreciating differences in backgrounds, experiences, and perspectives among students and colleagues.

**CONFIDENTIALITY:**

Faculty members should maintain the confidentiality of student information, respecting students' privacy rights. Under prior permission from the institution's head, students' information could be disclosed only on a need-to-know basis.

**PROFESSIONAL COMPETENCE:**

Dental faculties must maintain the highest level of professional competence through continuing education and training.

**PROFESSIONAL INTEGRITY:**

Dental faculties must maintain their professional integrity by avoiding conflicts of interest, practicing honesty and transparency, and reporting unethical behavior.

**ACCOUNTABILITY:**

Faculty members should be accountable for their actions and decisions, taking responsibility for any mistakes or errors.

**BEHAVIOUR:**

It is prohibited for an employee to smoke or chew tobacco within the campus. Any kind of misbehavior or unlawful activity is unethical. Faculties should avoid any behavior that could be

considered discriminatory or harassing to students, colleagues, or patients.

**COMPLIANCE:**

Dental faculties must comply with all laws, regulations, and ethical standards related to their professional practice, and report any suspected violations or misconduct.

**PUNCTUALITY:**

Late arrival and early departure is against the basic principles of punctuality. Leaving the institution during office hours for personal work should be avoided. Unless an emergency, leaves should be applied with the permission of the HOD and the principal and due care should be taken to delegate their work to other colleagues.

**CODE OF CONDUCT FOR ADMINISTRATIVE STAFF**

**PROFESSIONALISM:**

All administrative staff members should conduct themselves in a professional manner at all times, including a professional dress code, being punctual, and displaying a positive attitude.

**HONESTY:**

Administrative staff must act with honesty, integrity, and transparency in all their actions with colleagues, parents, patients and other stakeholders, and should not engage in any form of fraud or deception.

**RESPONSIBILITY:**

Administrative staff should be responsible for their actions and work diligently to fulfill their duties to the best of their ability, while also adhering to established policies and procedures.

**COMPLIANCE:**

Administrative staff should comply with all relevant laws, regulations, and guidelines related to their work, including



those related to data protection, information security, and ethical conduct.

**REPORTING VIOLATIONS:**

All administrative staff must report any violations of the code of conduct, policies, or regulations to the appropriate authority.

**COMMUNICATION:**

Administrative staff should communicate clearly and effectively with colleagues, parents, patients and other stakeholders, and should ensure that they are available to answer questions and address concerns as needed.

**FAIRNESS AND IMPARTIALITY:**

Administrative staff must be fair and impartial with colleagues, patients, and all stakeholders. They must not exhibit any bias, favoritism, or prejudice.

**CONFIDENTIALITY:**

All confidential information must be protected and kept confidential. Administrative staff must maintain strict confidentiality regarding any sensitive information of the Institution and its stakeholders.

**CONFLICT OF INTEREST:**

Administrative staff members should avoid conflicts of interest and should not engage in activities that may compromise their professional integrity or the reputation of the organization.

**PROFESSIONAL BOUNDARIES:**

Administrative staff members should maintain appropriate professional boundaries with all stakeholders and should avoid any behavior that could be considered inappropriate or unethical.

**TEAMWORK:**

Administrative staff should work collaboratively with colleagues and other stakeholders to achieve the goals of the Institution and should strive hard to promote a respectful work

environment where all individuals are treated fairly and with dignity, regardless of their background, identity, or status.

## **CODE OF CONDUCT FOR SUPPORTING STAFFS**

### **PROFESSIONALISM:**

Support staff must maintain a high level of professionalism at all times, including dressing appropriately, being punctual, and displaying a positive attitude.

### **SAFETY AND SECURITY:**

Support staff must prioritize the safety and security of the premises, people and materials.

### **HONESTY AND INTEGRITY:**

Support staff must act with honesty, integrity, and transparency in all their actions.

### **RESPECT AND COURTESY:**

All support staff must treat co-workers, patients and all stakeholders with respect and courtesy, regardless of their position, gender, race, or any other personal characteristic.

### **CONFIDENTIALITY:**

Support staff must maintain confidentiality regarding any sensitive information of the Institution.

### **RESPECT FOR PROPERTY:**

Support staff must take care of all the Institution's properties like Dental chairs, instruments, equipment, electrical appliances etc., with due care and maintaining their cleanliness.

### **FOLLOWING INSTRUCTIONS:**

Support staff must follow the instructions given by their supervisors or managers in order to carry out their duties efficiently.

### **PERSONAL HYGIENE AND CLEANLINESS:**

Support staff must ensure that they are clean and hygienic, wear clean and neat uniforms, and maintain good personal hygiene.

**REPORTING VIOLATIONS:**

Support staff must report any violations of the code of conduct, policies, or regulations to the appropriate authority.
